- Full board and lodging incl. three balanced meals a day, 24-hour care services, laundry services and security.
- Spacious single rooms as well as 4 flats for maximum privacy.
- All facilities are accessible by wheelchair.
- An entertainment area is available for residents and functions.

Transport

A seatless combi, donated by the National Lottery, transports our residents for medical and personal appointments as well as for recreational outings.

Management

Robertson House is managed by a Management Committee consisting of elected volunteers from the public, residents and personnel of Robertson House. Meetings are held on a regular basis to ensure the best possible service to our residents. Dedicated personnel is responsible for the day-to-day running of the home.

Funding

Residents pay board and lodging fees to cover the above services. Robertson House is registered with the Department of Social Development and receives a monthly subsidy towards the board and lodging fees of 6 residents in receipt of a Disability Grant. The monthly running costs and expenses exceeds the above income, therefore Robertson House relies on the financial assistance from the public through fundraising projects.

It is not easy for residents to ask for financial assistance, therefore the Management Committee decided that Club 500 is a good opportunity for donors to assist a resident struggling to pay his board and lodging fees. A small donation goes a long way!

How does Club 500 work?

- Commit yourself to a monthly donation of R50.00 (or more) and support a resident in need.
- Membership is open to all, but limited to 500 members.
- A tax exemption certificate may be issued on request at the end of each financial year.
- All proceeds will be used to provide 24-hour care services to the residents of Robertson House.
- Theron Du Plessis are our appointed auditors.
- Robertson House is a Registered Branch of the Western Cape Association for Persons with Disabilities.
